DUE DILIGENCE AND CARE HAS BEEN EXERCIZED. THE UNDERSIGNED RELEASES CAIN'S DOG HOUSE, INC, ITS OWNERS, AND EMPLOYEES, FROM ALL RISKS AND DAMAGES, WHICH MAY OCCUR DURING YOUR PETS STAY.

SHOULD ANY PET BECOME ILL OR NEED MEDICAL ATTENTION, WE RESERVE THE RIGHT TO ADMINISTER AID AND TO RENDER CARE BY YOUR LOCAL DESIGNATED VETERINARIAN, IF AVAILABLE, OR BY OUR CHOSEN VETERINARIAN. ANY EXPENSES INCURRED, BEING REASONABLE IN AMOUNT, SHALL BE PAID PROMPTLY BY THE OWNER.

NO PET SHALL BE RELEASED UNTIL ALL CHARGES ARE PAID IN FULL. THE CUSTOMER AGREES TO NOTIFY US IN ADVANCE IF THERE IS ANY CHANGE IN THE PETS PICK UP DATE. ANY PET LEFT UNCALLED ON FOR SEVEN DAYS FROM THE SCHEDULED DATE OF PICK UP, AS NOTED HEREIN, SHALL BECOME THE PROPERTY OF THE KENNEL. FEES INCURRED FOR THE CARE AND DISPOSAL OF UNCALLED ON PETS WILL BE TURNED OVER TO COLLECTIONS.
